MESSAGE FROM THE DEAN

DEAR FRIENDS AND COLLEAGUES:

The UC Davis Graduate School of Management is proud to publish our sixth annual *UC Davis Study of California Women Business Leaders: A Census of Women Directors and Highest-Paid Executives*.

This study details the presence of women at the very top of the 400 largest publicly held corporations headquartered in the state. Our findings paint a disappointing picture: there is only one woman for every nine men among directors and highest-paid executives at these high-profile companies.

When we released our study each of the past five years, it was met with intense interest by the business community, state legislators and policy makers, and garnered widespread media coverage.

Yet there has been little improvement in the gender diversity of the upper echelons of decision makers at the largest public companies in California. These are several key findings of our 2010 census:

- Overall, women hold just 9.5% of board seats and highest-paid executive positions—in line with previous years in which we measured a broader category of corporate executives.
- More than one third, 141 (35.3%) of the 400 largest public companies in California have no women among their directors and highest-paid executives.
- Not a single company has an all-female board and management team.
- Sixteen (4.0%) of the 400 companies have a woman serving as CEO, up slightly from 15 CEOs in 2009, and showing some progress since 2006 (11 female CEOs).

Our results highlight the need for greater participation of women on corporate boards and in the executive suites, and to help create these opportunities. To improve the standing of women in business leadership positions, the Graduate School of Management has a strong partnership with Watermark, a nonprofit organization and network of exceptional women leaders seeking to grow their personal impact in their professions and in society. Watermark offers several pioneering programs to increase the number of women in executive and board roles and support them in those roles.

At the UC Davis Graduate School of Management, we take our job of teaching future business leaders—both women and men—very seriously. One of our goals is to help our MBA students prepare for and succeed in the upper ranks of business.

Our business school community is built on a foundation of excellence and diversity. Our faculty is now 45% female, the highest percentage among the top 100 global business schools, according to *The Financial Times* Global MBA 2010 survey. *The Princeton Review* also has recognized the UC Davis MBA program as one of nation's top 10 offering the "greatest opportunity for women"—in 2009 we were ranked among the top 5 in the U.S. and the No. 1 business school in California in this regard. When our MBA students graduate and look for opportunities, they will be terrific resources for companies headquartered in California and beyond.

In today's global marketplace, where diverse backgrounds, skills and experience are critical for strategic and operational decisions, having more women involved at the highest levels of business management and corporate governance can only result in more profitable and well-managed corporations. Our mission is to help make that a reality.

For the past six years, Watermark (formerly known as the Forum for Women Entrepreneurs & Executives), has been proud to partner with the UC Davis Graduate School of Management to publish the annual *UC Davis Study of California Women Business Leaders*.

The data presented in the study are aligned with Watermark's vision and values. We believe that the most innovative and successful organizations and communities are those that tap into, connect and empower talented women.

Each year, it has been disappointing to see that the representation of women in the executive suites and in the boardrooms of California's largest 400 public companies remains stagnant—with no significant improvement. This year's census creates another opportunity for companies to understand the value of diversity in top leadership ranks, and the need to create a corporate culture that identifies the bias on all sides that might be affecting change.

Why is it critical for organizations to support more women in leadership?

Studies show that greater diversity company-wide improves measured risk taking, makes for better decision making and leads to healthier companies overall.

Research from Catalyst, McKinsey and others shows that companies with the highest representation of women on their top management teams experience stronger financial performance when compared to companies with the lowest representation of women in senior positions: return on equity is 35% higher and total return to shareholders is 34% higher for companies with more senior women executives.

More significantly, women are increasing both their spending and earning power. Women make up 85% of household purchasing decisions, half of the non-farm labor workforce and half of higher paying management and professional positions. Companies woo the female dollar yet women still have little or no representation in their C-suites or on their boards.

INTRODUCTION

Our sixth annual *UC Davis Study of California Women Business Leaders: A Census of Women Directors and Highest-Paid Executives* reports on the status of women in the top decision-making positions of California's largest public companies.

Progress is gradual since our last census. Women comprise just 9.5% of the directors and highest-paid executives of the 400 largest companies in the state.

There has been slight progress with women directors, who now comprise 10.0% board seats, up from 9.8% in 2009, and continuing a modest upward trend from 8.8% in 2006. Of the 342 companies that were also in last year's census, 11 companies have fewer women directors this year, and 19 have more women directors.

For executive officers, we find 8.8% of highest-paid executive positions held by women. However, this percentage is not directly comparable to the figure we reported last year because of a methodological change in the study. This year we limited our examination to highest-paid executives. As a measure of women in management, the highest-paid executive team facilitates comparisons across firms, since the rules for inclusion of these five highest-paid executives are codified by the Securities and Exchange Commission (SEC) filing requirements.

Highest-paid executive positions include the chief executive officer (CEO), the chief financial officer (CFO) and the three other most highly compensated executives. In unreported analyses conducted on last year's 400 firms, women represented 8.4% of highest-paid executives. This year, women hold 8.8% of highest-paid executive positions at the 400 largest public companies, showing a slight improvement in representation at this highest level of management. In our 2010 census, 35 firms have two or more women highest-paid executives, and 16 firms have a woman serving as CEO, while almost two-thirds of the largest 400 companies in California have all-male highest-paid executive teams.

As in previous years, there is substantial variation in the representation of women across different company sizes, industry sectors and counties across in the state. The largest companies based on market capitalization continue to have about three times as many women directors as the smallest companies, but there is not a clear relationship between company size and percentage of highest-paid women executives. The very largest and very smallest firms in our sample have almost the same percentage of highest-paid women executives, 10.1% and 10.2%, respectively.

Companies in the real estate industry have the highest percentage of women directors, followed closely by the finance and health industries. The consumer products and services industry has the highest percentage of highest-paid women executives (almost one in five is a woman), followed by the media and entertainment industry.

Once again, the high-tech industries trail behind, with a notable 78% of the telecommunications industry having all-male boards. Similarly, 83% of electronic hardware companies, 78% of business services companies and 76% of firms in the software industry have all-male highest-paid executive teams.

Our study continues to paint a modest picture of the representation of women in corporate leadership, but the census does reveal slight progress and opportunities to celebrate the successes of women. Our Top 25 companies all have at least 25% women on their boards and highest-paid executive teams, and 11 of them are run by a woman CEO.

METHODOLOGY

The sample of companies used in the 2010 *UC Davis Study of California Women Business Leaders* consists of the largest 400 California companies, as measured by market capitalization in June 2010. Each firm's market capitalization on June 1 was obtained from the BoardEx database, which is produced by Management Diagnostics Limited, a London-based corporate research company.

The information in BoardEx was compiled largely from the companies' filings with the Securities and Exchange Commission (SEC). Specifically, the information used in this report can be found in each company's Definitive Proxy Report, (DEF-14A), which is a required supplement to the annual report. Where such data was unavailable from BoardEx, we gleaned the information directly from the SEC filings (47% of the firms). We used the SEC's online EDGAR database to access each company's most recent DEF 14-A filing. The BoardEx data reflect changes made prior to June 1, 2010. The SEC data reflect changes included in the most recent filing for a fiscal year ended prior to June 1, 2010.

This year we restricted our analysis of executives to the highest-paid executives designated in SEC filings. Highest-paid executives include the chief executive officer (CEO), the chief financial officer (CFO), and the three other most highly compensated executives. In addition, executives who would have qualified for this definition if they had served in the position for the entire fiscal year must also be listed in the DEF 14-A filing. In previous years, we collected and analyzed highest-paid executive data, although these analyses were unreported.

Companies that were no longer registered with the SEC in September 2010 were not included in the sample. Companies that did not have highest-paid executive data in BoardEx and also appeared to be delinquent in their SEC filings were not included in the sample.

Changes in directors and highest-paid executives that were made on or after June 1, 2009, and within the most recent fiscal year ended prior to June 1, 2010, are reflected in our 2010 census.

All reasonable steps have been taken to confirm the data and ensure their accuracy. Any remaining errors or omissions are the sole responsibility of the researchers.

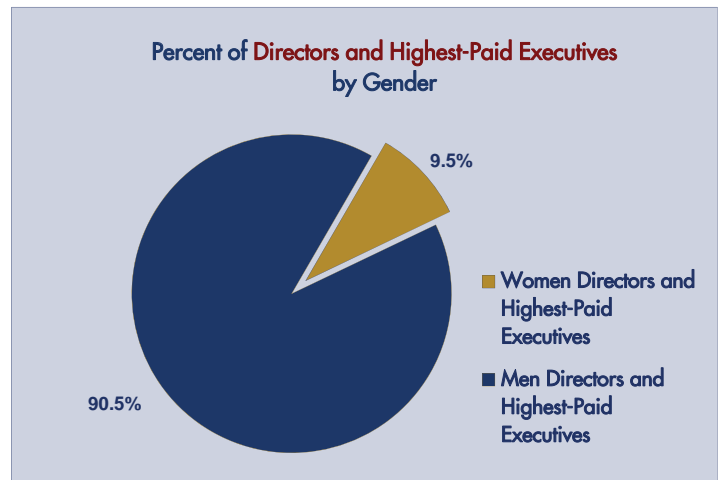
2010 EXECUTIVE SUMMARY

Directors and Highest-Paid Executives

- Women hold only 9.5% of the board seats and highest-paid executive positions in the 400 largest public companies headquartered in California.
- 141 (35.3%) of the 400 largest public companies in California have no women among their directors and highest-paid executives.

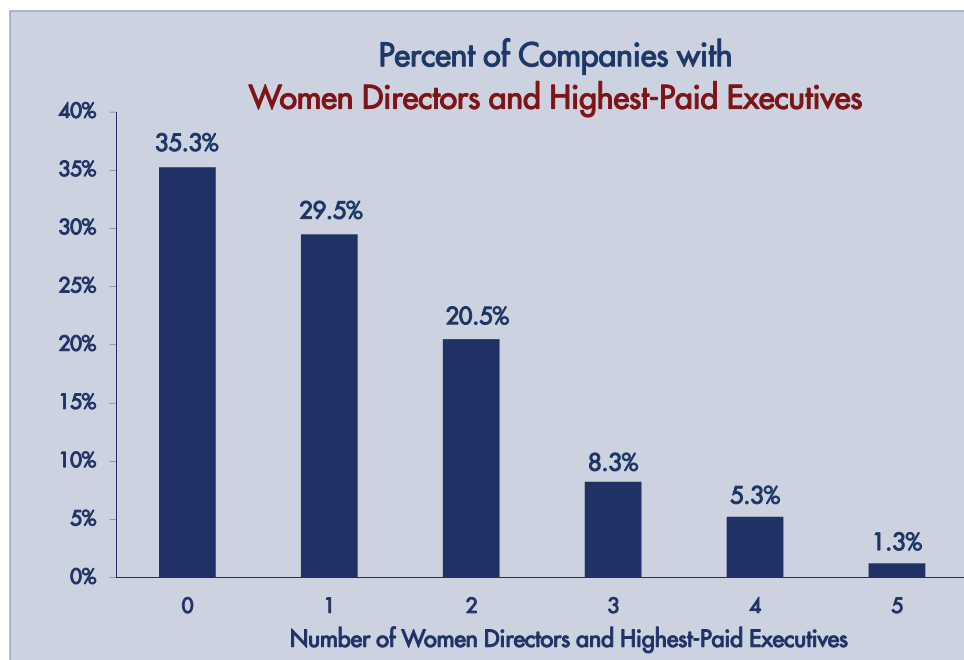
Directors

- Women hold 10.0% of the 3,266 board seats in the 400 largest public companies in California.
- Almost half (45.8%) of California's companies have no women directors.
- 32.5% of the 400 companies have only one woman director.
- Compared to our 2009 report, the percentage of women directors has increased slightly from 9.8% to 10.0% this year.



Highest-Paid Executives

- Women account for 8.8% of the 1,870 highest-paid executives in the 400 largest public companies in California.
- Two-thirds, 68.3%, of California's companies have no women among the highest-paid executives.
- Only 35 (8.8%) of the companies have two or more women among the highest-paid executives.
- Only 16 (4.0%) of the 400 largest public companies in California have a woman serving as CEO.



Industry Makes a Difference

- The real estate sector has the highest percentage of women directors, 14.4%. The finance sector ranks second with 14.0%.
- The telecommunications sector has the lowest percentage of women directors with 2.9%.
- The consumer products and services sector has the highest percentage of highest-paid women executives, 18.3%.
- The media and entertainment sector follows with 15.1%.
- Only 4.1% of highest-paid executives in the electronic hardware sector are women.

Company Size Makes a Difference

- Overall, the largest companies have larger boards and four times as many women directors as the smallest companies (1.6 women on average versus 0.4).
- California has 11 Fortune 100 companies, all of which have at least one woman director.
- Companies with the smallest market capitalization (below \$275 million) have the smallest percentage of women board members, 5.6%.
- While the largest firms tend to have the highest percentage of women directors, the relationship between corporate size and the percentage of highest-paid women executives is not positive.
- The two highest market capitalization categories (above \$7 billion and between \$2.8 billion and \$7 billion) account for the third-highest percentage of highest-paid women executives (10.1%) and the lowest percentage of highest-paid women executives (3.4%), respectively. Companies in the lowest market capitalization category (below \$275 million) have the second-highest percentage of highest-paid women executives (10.2%).

Location Makes a Difference

- Most of California's largest companies are located in Southern California (45%) and the San Francisco Bay Area (52%).
- Among counties with at least 20 companies, the Bay Area has the county with the greatest percentage of women directors, San Francisco County (14.4%), and Orange County in Southern California has the least (7.0%).
- Among counties with at least 20 companies, San Mateo County in the Bay Area is the top locale for highest-paid women executives, with 12.6% highest-paid women executives.
- Orange County and Silicon Valley (Santa Clara County) have only 4.5% and 6.7% highest-paid women executives, respectively.

The Corporate Leaders of Gender Diversity in the Boardroom and Executive Suite

Although women are sorely underrepresented in the corporate boardrooms and top executive offices of the 400 largest public companies headquartered in California, there are firms that incorporate a significant percentage of women in their leadership. Our Top 25 list highlights the companies with the highest percentage of women leaders. At each of these companies women occupy more than 25% of the board seats and highest-paid executive positions.

The top four companies stand out for their commitment to incorporate women into key leadership roles. These companies each have women in at least 35% of their board seats and highest-paid executive positions.

The Top 25 companies cover a range of industries and sizes. They include a fast-food company (Jack in the Box Inc.), an entertainment company (Walt Disney Co.), a public utility (American States Water Co.) and three biopharmaceutical firms (Affymax Inc., Amylin Pharmaceuticals Inc., and Onyx Pharmaceuticals Inc.). They also include some of the largest California companies (such as McKesson Corp. and Clorox Co.) as well as some of the smaller companies in our sample (such as Hot Topic Inc. and AMN Healthcare Services Inc.).

Eleven of the Top 25 companies and six of the top eight companies have a woman serving as CEO, suggesting that women in the top position include more women on their leadership teams.

Comparing the Top 25 in 2009 and 2010

- 19 companies made the Top 25 for two consecutive years.
- Two of the four companies that topped our list in 2009, bebe stores Inc. and Affymax Inc., topped the list again this year, with bebe stores Inc. moving from fourth to first.
- Six companies are new to the list, all of which were in last year's census.
- Six companies on last year's Top 25 list did not appear on this year's list. Three were not included in this year's census. Three companies were included in this year's census but dropped in rank, primarily due to a methodology change.

With so few women business leaders, the loss of even one or two from a company can have a significant impact on the gender diversity of its board room and executive suite.

WOMEN BOARD DIRECTORS: SUMMARY

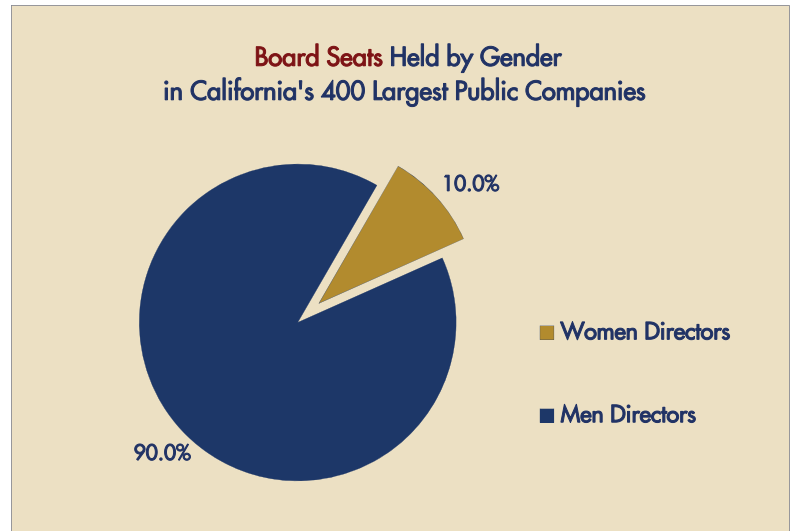
Women, for all their economic clout, continue to play a very limited role in corporate governance in California's 400 largest public companies. Among directors at these firms, only 10.0%, or 326, of the 3,266 board seats are held by women.

The size of boards of directors of California's largest companies ranges from four to 16, with an average of eight members per board.

The percentage of women directors increased slightly from 9.8% in 2009 to 10.0% in 2010.

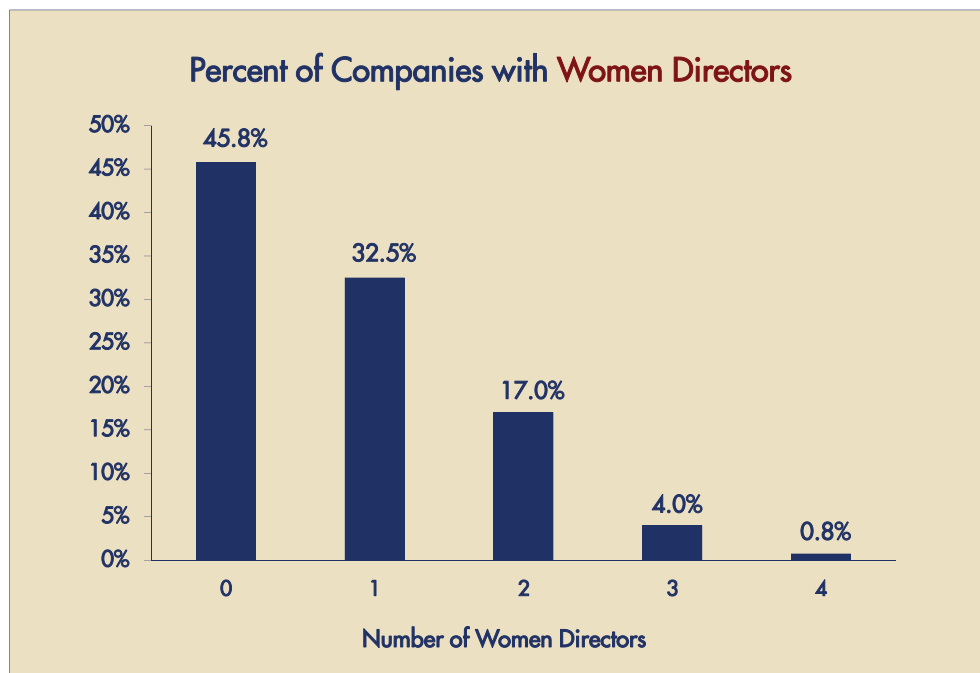
Of the 342 companies that were also in the 2009 census, 11 companies have fewer woman directors while 19 companies have more women directors.

When firms added new directors, though, the likelihood that they chose a woman exceeded the percentage of women directors in the full population. One hundred and fifty-nine companies added 274 directors since the last census and 34 (12.4%) of them were women. This suggests that firms that replace existing directors or expand the size of their boards on average increase the representation of women on their boards.

WHO ARE THE WOMEN DIRECTORS?

Most women who serve on the boards of the 400 largest public companies in California serve only on one board in our census, many of these women serve on multiple boards across the country. Of the 3,266 director positions at the 400 companies, 326 positions are held by 290 women. Of these, 96 women (33.1%) sit on the board of at least one company in the 2010 Fortune 500, and furthermore 58 women (20.0%) hold exactly one board seat among Fortune 500 firms, 26 women (9.0%) hold two such seats, nine women (3.1%) hold three such seats, and three women (1.0%) each hold four such seats.

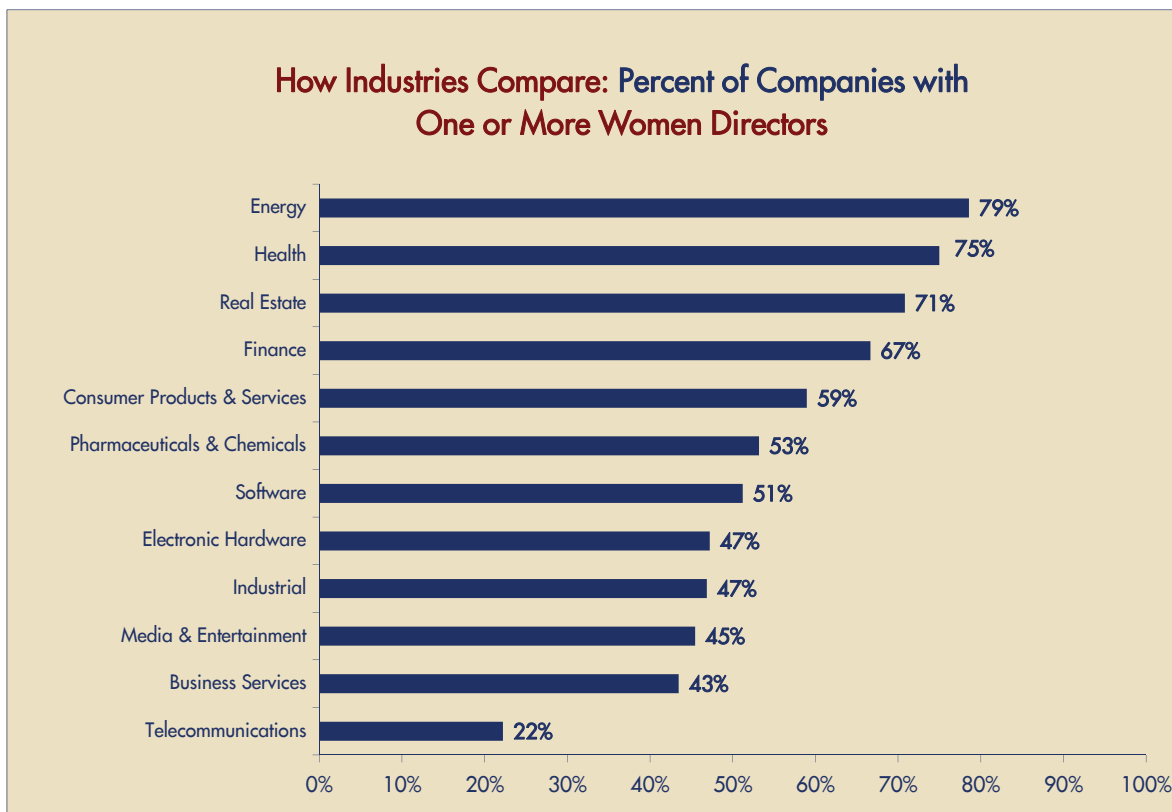
WOMEN BOARD DIRECTORS BY INDUSTRY

More than one-half (54.3%) of the 400 largest public companies in California have at least one woman director. But there is more to this story. When the companies are categorized by industry, the data reveal a wide variation of representation of women in the boardrooms of companies across sectors.

The information in this year's report comes from the BoardEx database produced by management Diagnostics Limited. The BoardEx Industry Classification was used to sort companies by industry. We have grouped companies into 12 broad categories so that there are at least 10 companies in almost every industry. The telecommunications sector has the fewest companies (nine) and the electronic hardware sector has the most (108).

Key Statistics

- The energy sector has the largest percentage of companies, 11 out of 14 (79%), with at least one woman director, although only four of these companies—American States Water Co., California Water Services Group, Edison International, and PG&E Corp.—have more than one woman director.
- The health, real estate, and finance sectors follow with 75%, 71% and 67% of their companies, respectively, having at least one woman director. One-fifth (five of 28) of the health sector firms and one-half of the real estate and finance firms have more than one woman director (10 of 24, and 11 of 24, respectively.).
- At the other end of the spectrum, only two (22%) companies in the telecommunications sector have at least one woman director. Firms in this sector were least likely to have at least one woman director last year as well. In all other industries, at least 40% of companies have one or more women directors.



WOMEN BOARD DIRECTORS BY INDUSTRY

Among the 400 largest public companies in California, no single industry has more than one woman for every five men on the board of directors on average.

Women are significantly less likely to be present in the boardrooms of telecommunications companies, with women representing only 2.9% of directors. Women also represent only 8.0% and 8.3% of directors in the electronic hardware and industrial sectors, respectively. The industry with the highest overall percentages of women directors is the real estate sector with 14.4%. The real estate sector was also among the top three sectors with women directors in our 2009 census. This year the media and entertainment sector is something of an anomaly, having the third to lowest percentage of firms with at least one woman director but having the fourth highest percentage of total women directors. This reflects the fact that the few media and entertainment firms that have of least one woman director, have a very high (relative to other firms) percentage of women directors, including Walt Disney Holding Co., which ranks 16th overall in our study.

WOMEN BOARD DIRECTORS BY COMPANY SIZE

There is a link between corporate size and the percentage of women on the board of directors. On average, large companies have larger boards and a greater representation of women on those boards. The positive relationship between size and the representation of women on the board is clear whether size is measured by total revenue or market capitalization.

We determine whether the firms in our study appear on *Fortune* magazine's list of the largest companies, as measured by total revenue.

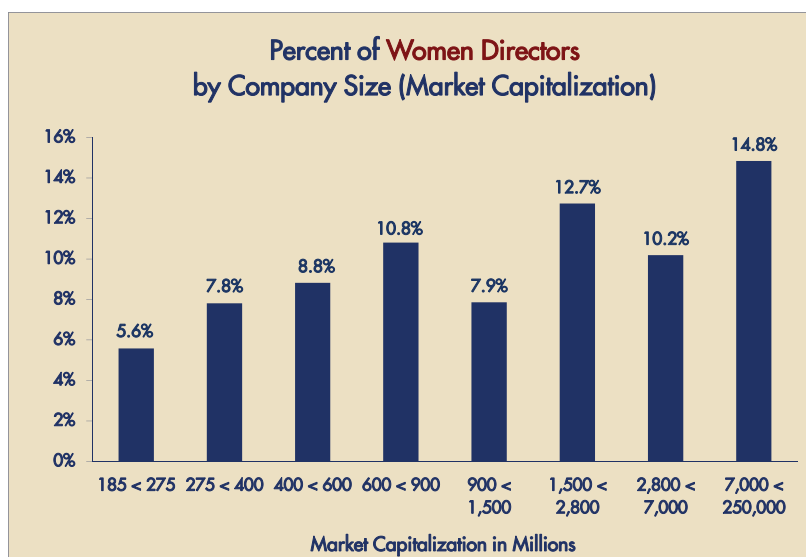
Eighty-seven of our California companies are on the Fortune 1000 list. There are 11 California public companies on the Fortune 100 list, 40 on the Fortune 101–500 list and 36 on the Fortune 501–1000 list.

We also determined the market capitalization of the firms in our study and categorized firms into three broad market cap categories. There are three large-cap categories: \$1.5 billion to 2.8 billion (45 companies), \$2.8 billion to \$7 billion (48 companies), and \$7 billion to \$250 billion (47 companies). The largest market capitalization in our study was \$237 billion.

There are two mid-cap categories: \$600 million to \$900 million (48 companies) and \$900 million to \$1.5 billion (52 companies).

There are three small-cap categories: \$185 million to \$275 million (53 companies), \$275 to \$400 million (52 companies), and \$400 million to \$600 million (55 companies). The smallest market capitalization in our study was \$188 million.

- All of the California Fortune 100 companies have at least one woman director. These 11 companies have boards composed of 20.0% women, on average. Of the Fortune 101–500 companies, 87.5% (35 of 40) have at least one woman director, with an average of 14.1% women directors. Of the Fortune 501–1000 firms, 75.0% (27 of 36) have at least one woman director, with an average of 10.9% women directors.
- The three large-cap categories (market capitalization greater than \$1.5 billion) have the largest boards, averaging 8.2, 8.8 and 10.9, respectively, and some of the highest average percentages of women directors. As a group, these 140 companies average 12.7% women directors, where 104 companies (74.3%) have at least one woman director and 46 companies (32.9%) have two or more women board members.
- The two mid-cap categories (\$600 million to \$1.5 billion) average 10.8% and 7.9% women directors, respectively. These companies have boards with 7.7 and 7.8 members, respectively on average; almost half (49.0%) of these 100 companies have no women directors.
- The three small-cap categories (below \$600 million) have about seven-member boards on average, and 5.6%, 7.8% and 8.8% of their board seats, respectively, on average, are filled by women.
 - > The majority (61.3%) of these 160 companies have no women board members.
 - > Only 21 (13.1%) of these companies have more than one woman director (Affymax Inc., Arena Pharmaceuticals Inc., bebe stores Inc., Big 5 Sporting Goods Corp., Biotime Inc., Celera Corp., Dine Equity Inc., DTS Inc., Echelon Corp., Electro Rent Corp., Genomic Health Inc., Genoptix Inc., Hot Topic Inc., LTC Properties Inc., McClatchy Co., Move Inc., Omnicell Inc., Peets Coffee & Tea Inc., West Marine Inc., Wilshire Bancorp Inc., Xenoport Inc.).

Overall, the largest companies have four times as many women directors as the smallest companies (1.6 women on average versus 0.4).

WOMEN BOARD DIRECTORS BY LOCATION

The majority of the 400 largest public companies in California are located in the San Francisco Bay Area (208) and in Southern California (178). The remaining are headquartered in Central Valley counties (five) and along the Central Coast (nine). Below we report the key statistics. Comparisons involving counties with only a small number of companies should be interpreted with caution.

Key Statistics

- Firms headquartered in the Bay Area have about the same percentage of women directors as firms located in Southern California (9.8% versus 10.0%). There are too few firms headquartered in the Central Coast and Central Valley regions to make judicious comparisons involving firms in these regions.
- Focusing on counties with more than 20 companies, San Francisco County has the highest percentage of women board members (14.4%), while Silicon Valley (Santa Clara County), San Mateo County and Orange County have the lowest percentage of women board members (8.9%, 8.5% and 7.0%, respectively).

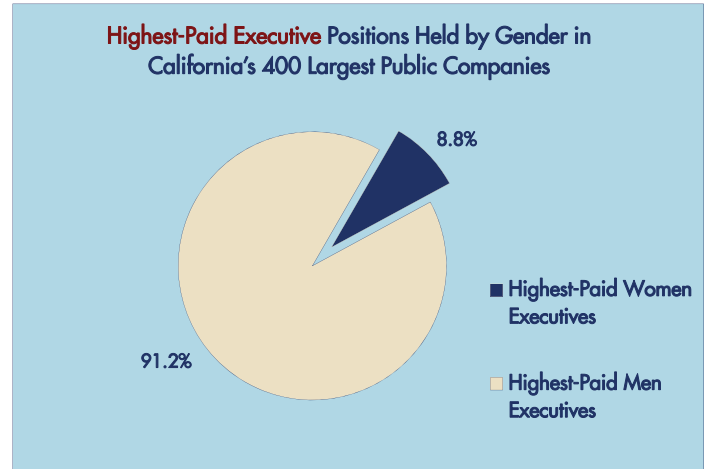

HIGHEST-PAID WOMEN EXECUTIVES: SUMMARY

Women executives in California's 400 largest public companies continue to be relatively scarce. This year we examine only highest-paid executive positions. See the Methodology for more information.

Women account for only 8.8% (164) of the 1,870 highest-paid executives in these firms. This percentage of women is not directly comparable to the figure we reported in 2009, which measured women in all executive positions. It is, though, comparable to unreported analyses conducted last year, which show that women accounted for 8.4% of highest-paid executives in 2009. This indicates that the percentage of women among highest-paid executives has increased slightly, by 0.4%, in the last year.

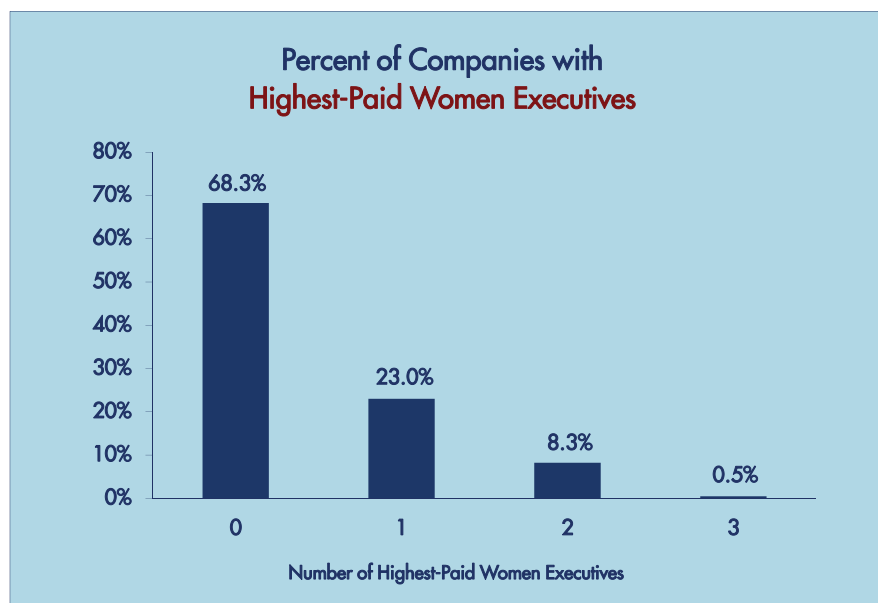


Of the 342 companies in our study that were also in the 2009 census, 327 have the same number of highest-paid women executives, seven companies have fewer women among the highest-paid executives, and eight companies have more women among highest-paid executives.

These highest-paid executive positions include the chief executive officer (CEO), the chief financial officer (CFO) and the three other most highly compensated executives.

- Two-thirds (68.3%) of California's 400 largest public companies have no women among the highest-paid executives.
- Another 23.0% of the state's companies have only one woman among the highest-paid executives.
- Only 35 (8.8%) companies have two or more women among the highest-paid executives.

Two-thirds, or 273, of the state's 400 largest public companies have no women among the highest-paid executives. These companies report 4.6 male highest-paid executives each, on average.

- Of the 342 companies that were also in the 2009 census, 233 (68.1%) have no women among the highest-paid executives in 2010. Of these 233, 229 (98.3%) also had no women among the highest-paid executives in 2009. The remaining four (1.7%) had one woman among the highest-paid executives in 2009, but lost a woman in the last year.
- Of the 58 companies that were not in the 2009 census, 40 (69.0%) have no women among the highest-paid executives in 2010.

WOMEN IN THE MOST IMPORTANT CORPORATE ROLES

Of the 400 largest public companies in California, 16 are led by women chief executive officers, up from 15 in 2009. Fourteen of these women were on last year's list. Two of these women were not on last year's list. One woman who was on last year's list does not appear on this year's list.

- Of the two women appearing on the CEO list for the first time, only one (Laura Alber) heads a firm (Williams-Sonoma Inc.) that was in last year's census. The other woman (Sylvia Dubrevil Summers) heads a firm (Trident Microsystems) that was added to the census this year. Both women are new their roles.
- One woman who was on last year's list does not appear on this year's list because the company was acquired by a firm outside of California.
- Several of the women CEOs have multiple roles (CEO and president, or chairman and CEO).
- The CFO category has the most women (35).

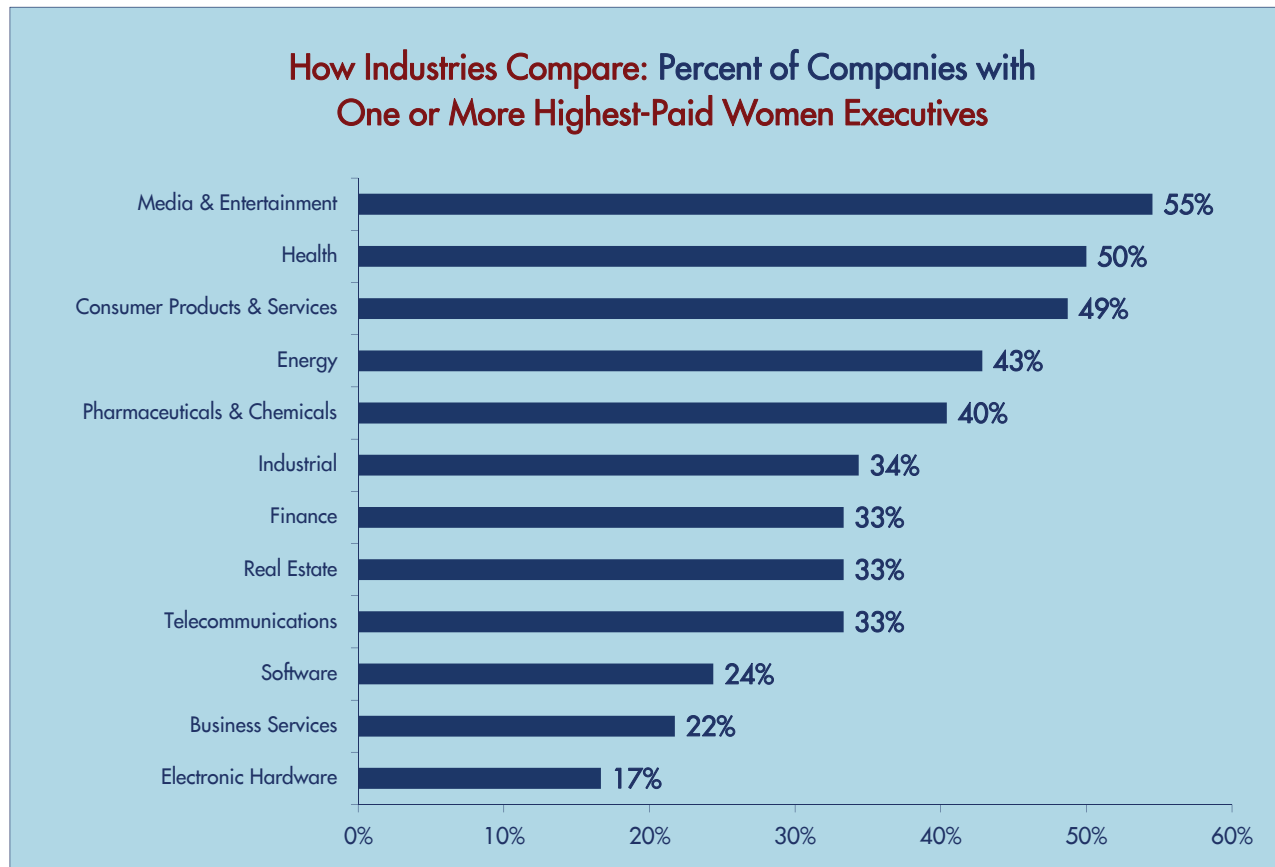

HIGHEST-PAID WOMEN EXECUTIVES BY INDUSTRY

Slightly fewer than one-third (31.8%) of California's 400 largest public companies have at least one highest-paid woman executive. When the companies are categorized by industry, there is wide variation in the percentage of companies with highest-paid women executives. Thirty-eight percentage points separate the industry whose firms are most likely to have at least one highest-paid woman executive (55%) from the industry whose firms are least likely to have at least one highest-paid woman executive (17%).



- Among the 12 industrial sectors we identify, the 11 media and entertainment companies were the most likely (55%) to have at least one highest-paid woman executive in 2010. In the health sector and the consumer products and services sector 50% and 49% of firms, respectively, have at least one highest-paid woman executive.
- The 108 electronic hardware companies were the least likely (17%) to have at least one highest-paid woman executive in 2010. In the software and business services sectors, 24% and 22% of firms, respectively, have at least one highest-paid woman executive.

HIGHEST-PAID WOMEN EXECUTIVES BY INDUSTRY

Key Statistics

- The consumer products and services sector has the greatest percentage of highest-paid women executives. For the 39 companies in this sector, almost one in five highest-paid executives is a woman (18.3%).
- Firms in the media and entertainment sector have the second highest percentage of highest-paid women executives (15.1%). Thus, firms in this industry stand out both as being the most likely to have women in their highest-paid management teams and as having a relatively high percentage of highest-paid women executives.
- Firms in the electronic hardware, business services, and software sectors have the lowest percentages of highest-paid women executives (4.1%, 4.8% and 6.4%, respectively). Across these three industries, fewer than one in 20 highest-paid executives is a woman, on average.

HIGHEST-PAID WOMEN EXECUTIVES BY COMPANY SIZE

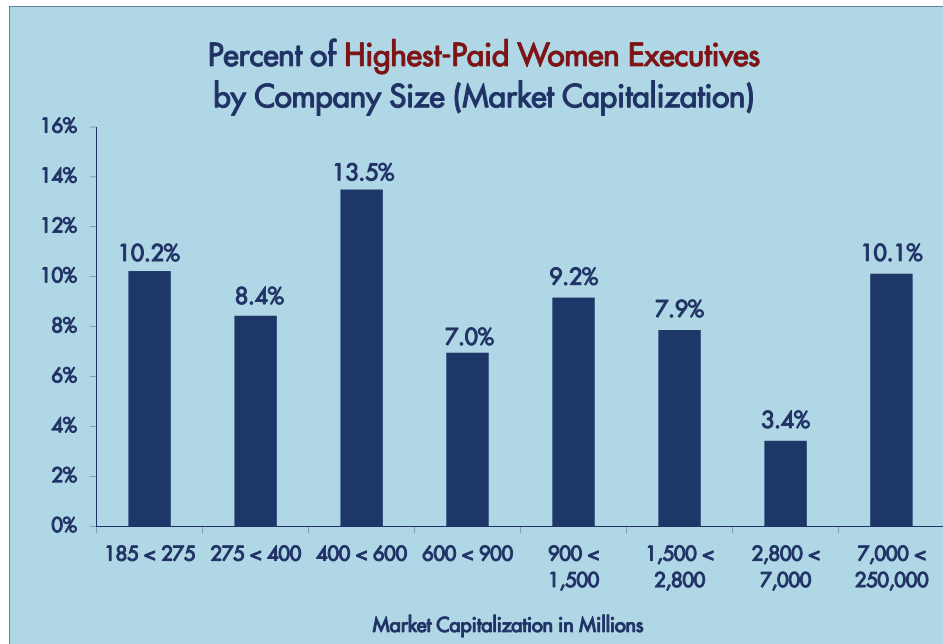
While large companies tend to have both larger boards and a greater representation of women on their boards, the relationship between firm size and the representation of women in highest-paid executive suites among California's 400 largest public companies is not positive. Indeed, the largest and smallest firms as measured by market capitalization have almost the same percentage of highest-paid women executives.

Key Statistics

- Six of the 11 California companies in the Fortune 100 have no women among the highest-paid executives: Apple Inc., Cisco Systems Inc., Ingram Micro Inc., Intel Corp., Northrop Grumman Corp. and Wells Fargo Co. Two of the Fortune 100 companies have two women on their highest-paid executive teams: Hewlett-Packard Co. and Safeway Inc. On average, the Fortune 100 companies have 13.7% highest-paid women executives. The Fortune 101 – 500 companies have an average of 8.1% highest-paid women executives and the Fortune 501 – 1000 companies have an average of 10.6%.
- The three categories of large-cap companies (market capitalization greater than \$1.5 billion) have average percentages of highest-paid women executives that range averages between 3.4% and 10.1%. Almost 8% of the large companies (11 of 140) have two or more highest-paid women executives. Notably, firms in the second-largest size category have the lowest representation of women among highest-paid executives (3.4%). Firms in this category (\$2.8 billion to \$7 billion) are significantly more likely than in any other category to have no women among the highest-paid executives (87.5%).
- The two categories of mid-cap companies (\$600 million to \$1.5 billion) average 7.0% and 9.2% women among the highest-paid executives. Seven of these companies (7.0%) have two or more highest-paid women executives.
- The three categories of small-cap companies (below \$600 million) have women serving in 8.4% to 13.5% of highest-paid executive posts. More than one-tenth (10.6%) of these companies have two or more women among the highest-paid executives. The smallest firms, those with market capitalization below \$275 million, have the second highest percentage of women among the highest-paid executives, 10.2%.

HIGHEST-PAID WOMEN EXECUTIVES BY LOCATION

The number of highest-paid women executives at the largest public companies in California varies considerably at the county level. Below we report the key statistics, again noting that comparisons involving counties with small numbers of companies should be made with caution.

Key Statistics

- The Bay Area and Southern California companies have approximately the same percentage (8.9% and 8.6%, respectively) women among the highest-paid executives.
- Focusing on counties with at least 20 companies, San Mateo County has the greatest percentage of highest-paid women executives (12.9%), while Orange County and Silicon Valley (Santa Clara County) have the lowest percentages (4.5% and 12.6%, respectively).

CONCLUSION

As in past years, the 2010 census shows that women occupy only a small minority of the board and top management positions in California's 400 largest corporations. Among these companies, there is variation in the representation of women in the board seats and highest-paid executive positions, ranging from no women at all (141 firms, or 35% of the sample) to equal shares of men and women (1 firm, or 0.25% of the sample). This variation can be attributed partly to differences in the primary industries, headquarters locations, and sizes of firms. Firms in the high-tech industries and located in Silicon Valley tend to include fewer women on the board and in top management. The largest firms tend to have more women directors and managers. These results are consistent with the findings from previous years.

Time Trend

Examining the census results over time, there is relatively little variation. For the past five years, the percentage of women on the boards of California's largest 400 firms has hovered around 10%. Although not reported in 2010, the proportion of women in the top management teams of these firms has fluctuated around slightly less than 12%. This year we report the share of women among the highest-paid executives, which has wavered just below 9% in the last four years (using previously unreported data). See the accompanying graph, page 26.

It appears that individual companies are slow to change. Approximately 91% of the 342 firms included in this and last year's census had the same number of women directors in 2009 and 2010. Approximately 96% of the firms included in this and last year's census had the same number of women highest-paid executives. Although 19 firms had more women on their boards this year than last year, 11 firms had fewer women on their boards. Additionally, while 8 firms had more women in their highest-paid management teams this year than last year, 7 had fewer. This stability was reflected in the correlation between the representation of women in 2009 and 2010 among the firms in our census in both years. The correlation between the numbers of women directors in the two years was 0.94 (where a correlation of 1.0 represents a perfect association). The correlation between the numbers of women highest-paid executives across the two years was also 0.94.

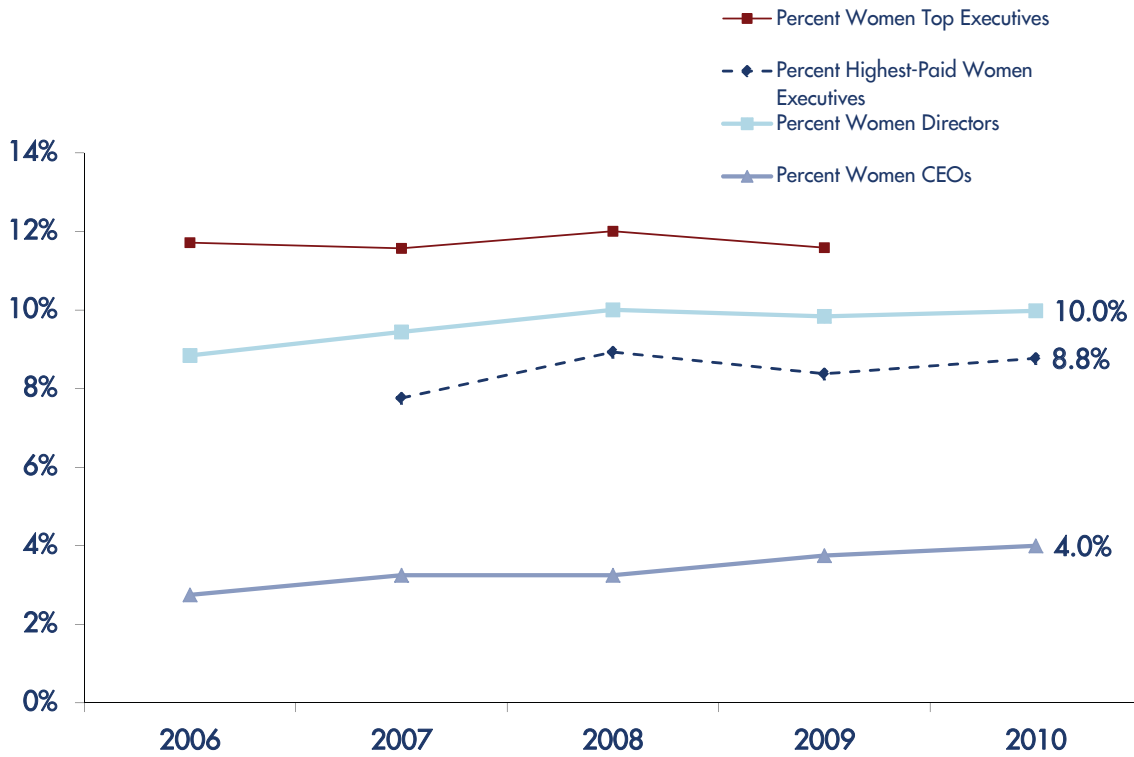
A Sign of Hope?

Although there has been relatively little change in the representation of women on the boards and top management teams of California's largest 400 firms over time, the little change that is visible points towards greater incorporation of women in the leadership of California's largest firms.

The firms in our sample hired 274 new directors this year, which was offset by 212 director positions vacated this year. Of the new directors, 12.4% are women. Thus, when firms added new directors, the likelihood that they chose a woman exceeded the percentage of women directors in the full population.

Similarly, 79 of the highest-paid executives in our census are new to the category this year, and 12.7% of these newly highest-paid executives are women. Thus, when an individual became one of the highest-paid executives (whether through promotion, enlistment, or attrition) the likelihood of that individual being female exceeded the percentage of women in this category in the full population. These observations show that firms have been increasing the representation of women, albeit at an extremely modest pace. Whether this modest trend will accelerate, hold steady, or stall is an open question for our census in future years.
